A. SENDING AND RECEIVING INSTITUTIONS

B. ADMISSION REQUIREMENTS FOR SENIOR COLLEGE PROGRAM

An associate degree in a health science program of study with a minimum grade point average of 2.5, and appropriate Licensure or Certification in hand or pending;

OR

An associate degree from a program that has an articulation agreement with the New York City College of Technology (NYCCT) Health Sciences Administration program with a minimum grade point average of 2.5;

OR

An associate degree with a minimum grade point average of 2.5, and at least two years of alternative work experience in a health care setting or related field as determined by the Health Services Administration program coordinator.

Acceptance into this program will be under the requirements in effect at the time of admission and may be subject to such changes as shall be determined by City Tech's academic policies and curricula.

Articulation with the Borough of Manhattan Community College's (BMCC) Associate in Applied Science in Health Information Technology with the NYCCT's Bachelor of Science in Health Services Administration is based upon the following:

Students wishing to transfer under this articulation agreement must have obtained their associate degree and meet the minimum cumulative 2.5 GPA requirement.

Total transfer credits granted toward the baccalaureate degree: <u>67</u>
Total additional credits required at the senior college to complete baccalaureate degree: <u>53</u>
Total credits required for the B.S. in Health Services Administration: <u>120</u>

C. TRANSFER CREDIT AWARDED

Transferred credits will be applied to the baccalaureate degree as professional credits, course specific transfer credits and electives. Students will meet with an advisor who will review their transcripts to ensure appropriate placement within the program.

- Procedures for reviewing, updating, modifying or terminating agreement:
 When either of the degree programs involved in this agreement undergoes a change,
 the agreement will be reviewed and revised accordingly by representative from each
 institution's respective departments or programs, selected by their Chairpersons and/or
 program directors.
- 2. Procedures for evaluating agreement (i.e., tracking the number of students who transfer under the articulation agreement and their success):

 Each year, NYCCT will provide BMCC with the following information: a) the number of BMCC graduates who applied to the program; b) the number of BMCC students who were accepted into the program; c) the number of BMCC students who enrolled; and d) the aggregate GPA of these enrolled students at NYCCT.
- 3. Sending and receiving college procedures for publicizing agreement (e.g., college catalogs, transfer advisers, websites, etc.):
 - This articulation agreement will be publicized on the BMCC website and on the NYCCT website.
 - Transfer advisors at BMCC will promote this agreement with eligible students.
