Prerequisite and Course Descriptions

Prerequisites

A high school transcript must be submitted with each application. Eligible students will demonstrate: Strong record of attendance; no scheduling conflicts during the Fall 2019 semester and other requisites as noted below. For admissions to College Now college credit courses students must be **in good academic standing at their home schools (GPA 80+)** and have a good record of attendance. Furthermore, students must have demonstrated proficiency in the appropriate area(s) via SAT or Regents scores.

Admission to Math only:

Students must have

1. Scored 70+ in Algebra I (Common Core) **OR** scored 70+ in Geometry (Common Core) **OR** scored 65+ on Algebra II (Common Core)
OR
2. Scored 530+ on SAT/Math
OR
2. Scored 21+ on ACT Math

*All Math applicants are required to take the ACCUPLACER Math placement exam to determine level of proficiency in college Math.

Admission to Other college-credit courses:

Students must have

1. Scored 75+ on ELA Regents
OR
3. SAT I Verbal score of 480+ *or* SAT Critical Reading score of 480+ *or* SAT Evidence-Based Reading and Writing (EBRW) section score of 480+
OR
3. Scored 21+ on ACT English

Course Descriptions

ASL 1101 American Sign Language I (3 cl hrs, 3 cr)

A beginner course designed to develop skill in a form of manual communication used primarily by American-born deaf persons in interpersonal (face-to-face) relations. Emphasis will be placed on the use of the body for visually-based communications, and the structure, vocabulary and development of American Sign Language.

BIO 1101 Biology I (3 cl hrs, 3 lab hrs, 4 cr)

The fundamental principles of biology focus on topics including taxonomy, structure, nutrition, reproduction, heredity, development and evolution. The concepts of molecular biology and DNA fingerprinting using representative plants and animals are introduced. The course also includes the use and care of the microscope.

COM 1330 Public Speaking (3 cl hrs, 3 cr)

Practice in presenting extemporaneous speeches, textbook readings, preparation of speech outlines and reading of resource material for research in speech.

ECON 1401 Microeconomics (3 cl hrs, 3 cr)

The price system and capitalism. Demand, supply and elasticity, the costs of production and how these costs are determined under perfect competition, monopoly, monopolistic competition and oligopoly, factors of production under perfect competition and the various forms of monopoly.

ENG 1101 English Composition I (4 cl hrs, 3 cr)

This is a course in effective essay writing and basic research techniques, including use of the library. Demanding readings are assigned for classroom discussion and as a basis for essay writing.

ENT 1100 - Introduction to Entertainment Technology (3 cl hrs, 3 cr)

An introduction to the entertainment technology industry including working methods; processes, equipment and facilities for live, recorded, and interactive entertainment and media environments, including theatre, opera, dance, concert productions, theme parks, themed-retail, cruise ship venues, video production, immersive, interactive and virtual environments, and gaming technology. Students will investigate commercial, not for profit, independent, and corporate industry models. Related current events and career opportunities will be discussed. Attendance at several of the type of events listed above is required.

***ENT1100 does not require any regents scores. Any student with an 80+ GPA is qualified to take this course.**

LAW 1101 Introduction to Paralegal Studies (3 cl hrs, 3 cr)

An overview of the legal system and the role of the legal assistant within that system. Includes the sources of law; legal terminology; the operation of the court system at the state and federal level. Respective roles of attorney, client and paralegal.

MAT 1275 College Algebra/Trig (4 cl hrs, 4 cr)

An intermediate and advanced algebra course. Topics include quadratic equations, the distance and midpoint formula, graphing parabolas and circles, systems of linear and quadratic equations, an introduction to exponential and logarithmic functions. Topics from trigonometry including basic trigonometric functions, identities, equations and solutions of triangles.

***Math Prerequisite: Students must have scored 70+ in Algebra I (Common Core) OR scored 70+ in Geometry (Common Core) OR scored 65+ on Algebra II (Common Core) OR scored 530+ on SAT/Math OR scored 21+ on ACT Math.**

MKT 1100 Essentials of Marketing (3 cl hrs, 3 cr)

Functions involved in distributing goods, the role of the manufacturer in selecting target markets, types of marketing institutions (wholesale and retail). Formulating marketing policies and strategies. The role of government and the effects of consumerism on marketing practices.

PHYS 1117 - Astronomy I (3cl hrs, 2 lab hrs, 4 cr)

Astronomical history is presented including an introduction to the mechanics and optics of Galileo and Newton. Radiation laws and astronomical tools including the telescope are considered. The solar system is presented in detail as is a history of human space travel.

***Math Prerequisite: Students must have scored 70+ in Algebra I (Common Core) OR scored 70+ in Geometry (Common Core) OR scored 65+ on Algebra II (Common Core) OR scored 530+ on SAT/Math OR scored 21+ on ACT Math.**

AND

***English Prerequisite: scored 75+ on ELA Regents OR SAT I Verbal score of 480+ or SAT Critical Reading score of 480+ or SAT Evidence-Based Reading and Writing (EBRW) section score of 480+ OR scored 21+ on ACT English.**

PSY 1101 Introduction to Psychology (3 cl hrs, 3 cr)

Methodology, history and theories of psychology; brain and behavior; neuropsychology; socialization; motivation; emotion; perception; learning; thinking; intelligence; personality and the adjustment processes; and social psychology.

SOC 1101 Elements of Sociology (3 cl hrs, 3 cr)

Perspectives on sociology as an analytical science. The emphasis is on concepts, hypotheses and theories which explain social behavior and social change.

The College Now fall 2019 semester runs from September 2019 to December 2019. Students will be notified via mail and email of their acceptance to the program. Acceptance letters will include specific details regarding mandatory orientation and class start dates.
