Who is eligible for Federal Student Aid?

If you are not a U.S. citizen or U.S. national, you must have one of the following immigration statuses in order to qualify for federal student aid payments:

- U.S. permanent resident who has an I-151, I-551, or I-551C Resident Alien Card (Documentation must not be expired)
- An Arrival-Departure Record (I-94) stamped "Refugee, Asylum Granted, Indefinite Parole, Humanitarian Parole, Cuban-Haitian Entrant, or Conditional Entrant"
- Persons who have been designated "victims of human trafficking: or "battered immigrants-qualified aliens"

If you only have the following documents as proof of immigration status, you do not qualify for federal student aid funds:

- Notice of approval to apply for Permanent Residence (Form I-171 or I-464)
- Temporary Resident Card (Form I-688)
- Employment Authorization Card (Form I-688A or I688B)
- Family Unity Status (Form I-817)
- Arrival Departure Record (I-94) stamped with F-1, F-2 or M-1 Student Visa, B-1 or B-2 Visitor Visa, A-2 or A3 Visas, J-1 or J-2 Exchange Visitors Visa, or G, H, L, or U series Visas.
- Deferred Action for Childhood Arrivals (DACA)
- Temporary Protected Status
- Students with a withholding or removal order

VERIFICATION OF MY IMMIGRATION STATUS

It is the policy of City Tech to recruit, employ, retain, promote, and provide benefits to employees and to admit and provide services for students without regard to race, color, national or ethnic origin, religion, age, sex, sexual orientation, gender identity, marital status, disability, genetic predisposition or carrier status, alienage, citizenship, military or veteran status, unemployment status or status as a victim of domestic violence.

Why do I have to submit my immigration documents?

When you complete your Free Application for Federal Student Aid (FAFSA), the Department of Education (DOE) attempts to verify your eligible immigration status with the Department of Homeland Security (DHS), and Social Security Administration (SSA).

If the verification with DHS records is successful, your Student Aid Report (SAR) will reflect that your claim of an eligible immigration status has been confirmed.

If the verification is not successful, the Office of Financial Aid must collect a photocopy of your immigration documents and may be required to forward them to DHS so that they may verify the documents and confirm your status.

Federal regulations specify the types of documentation required to verify your immigration status (please see The Summary of Acceptable Documentation). A final decision about your financial aid eligibility will not be made until you have submitted your immigration status documents and they have been confirmed by DHS.

Certification Letter or Eligibility Letter (for Victims of Human Trafficking), I-94	Must be issued by Health and Human Services (HHS); cannot be expired; I-94 must b e stamped with T1, T2, T3, or TCOA code
Form I-797 or court order documents (for Battered Immigrants)	Court documents should be a "suspension of deportation" or a cancellation of removal"

Is there a deadline for me to submit my immigration documents?

YES! In order to receive federal financial aid payments for the current award period, the Office of Financial Aid **MUST** have received your FAFSA record and certified that the information entered into the FAFSA is complete and correct **by your last day of attendance** for the semester you are seeking a financial aid payment.

If your immigration documents have to be sent to DHS for status confirmation, they must be submitted while you are enrolled.

If your FAFSA is selected for verification, you have up to 120 days after your last day of attendance to submit any requested documentation including the documents supporting your claim of eligible immigration status.

NOTE: You will not be able to receive any disbursements of federal funds and no Direct Loan applications can be processed until the Financial Aid office has determined your FAFSA information, including the confirmation of your immigration status.
