Procedures for Student Evaluation of Teaching (SET)

The general procedures for administering the SET will be the same as in the previous semester.

1. This semester, every course-section will be evaluated.
2. For courses that run through the end of the semester, **the evaluation will begin on Monday, April 22nd and end on Wednesday, May 15th, 2024.** Please plan accordingly.
3. Students will be sent links directly via their City Tech emails to complete the SETs.
4. Students will receive a separate email and link for each of their enrolled courses.

We recommend:

- You set aside 10-15 minutes during class time for students to complete the SETs;
- You must not be in the room/meeting while the evaluation is taking place.

Student Evaluation of Teaching (SET) Notes

1. Emails will be sent from Scantron to student's campus email address.
 - a. Emails will be sent from:

 - ii. Address: **SPSSurveys@scantron.com**
 - b. Please see examples on the second page of this document.**
2. Regarding Synchronous and Asynchronous classes:
 - a. These two types of classes will be receiving different forms. These forms contain different questions that are specific to synchronous and asynchronous courses.
 - b. In synchronous courses with regular meeting times we recommend setting aside 10-15 minutes for students to access and fill out the evaluations.
 - c. In asynchronous courses we recommend posting a reminder for students to check their campus emails and fill out the evaluations.

Summary Reports

You will receive two email messages generated by CIS with links to view the results for each course that you teach (e.g., if you teach 5 courses, you will receive 5 email messages with 5 distinct links), as well as reports with student comments. CIS has indicated that **the link will expire within 30 days of sending the initial email message** to you. The two sets of links: 1) SET results and 2) student comment reports are scheduled to be sent within the first two weeks of classes during the Fall 2024 semester. Your Department Chair will also receive a copy of the SET reports and will note if we did not receive the forms for your section.
