2) In consideration of being allowed to separate from the end or remainder of the scheduled Program and any related activities, I do hereby, for myself and on behalf of my family, heirs and personal representative(s), RELEASE, INDEMNIFY AND HOLD HARMLESS City Tech, CUNY, the City of New York, the State of New York, and the officers, directors, employees, representatives, agents and affiliates of any and all of them ("Released Parties") FROM ANY AND ALL LIABILITIES, CLAIMS, DEMANDS, ACTIONS AND CAUSES OF ACTION WHATSOEVER arising out of or related to any loss, damage or injury (including death) to persons or property or both, caused by, deriving from, or associated with my separation from the Program and related activities, or which occur during the period when I otherwise would have been participating in the Program and/or related activities if I had not decided to end my participation early, including, without limitation, any travel incident thereto, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASED PARTIES OR OTHERS, except for such damages or injury as may be caused by the gross negligence or willful misconduct of the officers, directors, employees, representatives, agents or affiliates of any of the Released Parties.

3) I agree that this Waiver, Release and Indemnification Agreement ("Waiver and Release") is to be construed under the laws of the State of New York, that it is intended to be as broad and inclusive as permitted by the laws of the State of New York, and that if any portion hereof is held invalid, the balance hereof shall, notwithstanding, continue in full legal force and effect.

4) In signing this Waiver and Release I hereby acknowledge and represent that I have read this entire document, that I understand its terms and provisions, that by signing it I am giving up substantial legal rights I might otherwise have, that it is a binding agreement, and that I have signed it knowingly and voluntarily.
