Attendance

You must attend your classes to be eligible for financial aid. Fall and spring attendance is confirmed starting the first week of classes through the 21^{st} day of classes each semester. The WN (Never Attended) Grade will be assigned if your attendance is not confirmed. **Financial Aid will not pay for classes with WN Grades.**

Financial Aid (Federal Pell, SEOG, Direct Loans) Refund Dates

Please see Federal Work Study (FWS) payment calendar for FWS payment dates. Checks will be mailed directly to you (address we have on CUNYfirst) if you do not have direct deposit. Summer 2021 refunds for all financial aid programs will begin on July 23, 2021 and will be issued weekly as students become eligible.

Summer 2021, Fall 2021, and Spring 2022 Refund Schedule

If you withdraw from all classes during the semester and do not attend more than 60 percent of the semester (**November 6, 2021 for Fall 2021 and April 3, 2022 for Spring 2022**) you will be ineligible for **full** Federal Financial Aid (Federal Pell, SEOG, Direct Loans). Your awards will be **prorated** based on the number of days you attended during the semester.
