Attendance

You must attend your classes to be eligible for financial aid. Fall and Spring attendance is confirmed starting the first week of classes through the 21st day each semester. The WN (Never Attended) grade will be assigned if your attendance is not confirmed. **Financial Aid will not pay for classes with WN Grades.**

Financial Aid (Federal Pell, SEOG, Direct Loans) Refund Dates

Please see Federal Work Study (FWS) payment calendar for FWS payment dates. Checks will be mailed directly to you (address we have on CUNYfirst) if you do not have direct deposit. Summer 2025 refunds for all financial aid programs will begin on July 18, 2025 and will be issued weekly as students become eligible.

If you withdraw from all classes during the semester and do not attend more than 60 percent of the semester (**November 5, 2025 for Fall 2025 and April 12, 2026 for Spring 2026**), you will be ineligible for **full** Federal Financial Aid (Federal Pell, SEOG, Direct Loans). Your awards will be **prorated** based on the number of days you attended during the semester.
