## Loan Eligibility

- Your loan amount is based on the school's Cost of Attendance (COA) minus your financial aid and scholarships (based on your 2025–2026 FAFSA).
- You can't borrow more than your COA or the annual loan limits.
- If you received loans from another college for 2025–2026, your loan limit here will be reduced.
- Important:
- - You must stay enrolled in at least 6 credits per semester to keep your loan.
- - If you drop below 6 credits, your loan will be canceled and you'll be responsible for any unpaid tuition.
- If your financial aid later causes you to go over your COA or loan limits, your loan may be reduced or canceled, which could leave you with a balance.
