#### NEW YORK CITY FIRE DEPARTMENT BUREAU OF FIRE PREVENTION PUBLIC CERTIFICATION AND EDUCATION Alternative Issuance Procedure (AIP) Information for C-14

This document provides the procedures to follow in order to obtain a **Certificate of Fitness for Supervising Non-production Chemical Laboratories (C-14)** without a written exam administered by the New York City Fire Department.

Application for AIP must be submitted online. If the application meets all requirements, a Certificate of Fitness will be sent to the applicant's or company mailing address within five business days.

Applicants must understand that the Fire Department reserves the right to randomly call up to test the applicants who are issued by AIP. Applicant who has failed the written exam will not be allowed to take advantage of this policy.

## 1. <u>How to Apply</u>:

If you meet the requirements below you can submit an application(s) electronically online, through NYC Business Express - <u>https://www1.nyc.gov/nycbusiness/index#C</u> : (*a*) individually or (*b*) through FDNY approved employer's designated coordinator.

- a. An individual applicant can submit his/her own application. (If you are an individual, you can only submit your own application.)
- *b.* A designated coordinator (DC) can submit application(s) on behalf of the company's employees. The company's authorized DC must be approved by FDNY. To request approval, email to <u>arayae@fdny.nyc.gov</u>

# Qualification Requirements: (applicants must submit all supporting requirements electronically online) 2.1. Education, License and Experience Requirements

Applicants must have one of the following qualifications:

- License as a Clinical Laboratory Director from the NYS Dept. of Health; or
- Doctor of Medicine (MD) or Dental Surgery (DDS) or Doctor of Veterinary Medicine (DVM); or
- **Masters** or **Doctoral degree** in Chemistry, Biology, Biochemistry, Environmental or Health Sciences, Medical Technology and Chemical, Environmental, Mechanical or Biomedical Engineering, or related field <u>and</u>; or
- **Bachelor's degree** in Chemistry, Biology, Biochemistry, Environmental or Health Sciences, Medical Technology and Chemical, Environmental, Mechanical or Biomedical Engineering, or related field and **TWO years** of post-baccalaureate experience in the operation of chemical laboratories may apply for alternative issuance which is stated and signed by the employer/supervisor on a company official letter head. (*All claimed experience must be post baccalaureate. Any experience gained prior to the receipt of the degree will not be accepted towards meeting the AIP requirements.*)
- NY State Permanent Certification as a Chemistry or Biology (7-12) Teacher.

# (Degree issued from outside USA or is not in English shall be evaluated by an independent evaluation service accepted by NYC Fire Department.)

### 2.4. Application Fees

The application fee for C-14 is \$ 25. The following payment methods are acceptable:

- Credit Card (American Express, Discover, MasterCard, or Visa)
- Debit card (MasterCard or Visa)
- E-Check

For fee waivers submit: (Only government employees who will use their C of F for their work-related responsibilities are eligible for fee waivers.)

- An agency letter with official letter head; AND
- Copy of identification card issued by the agency

A convenience fee of 2.49% will be applied to all credit card payments.

#### 3. <u>Renewal Information</u>

FDNY also reserves the right to require the applicants to take a re-examination upon submission of the renewal application. This Certificate of Fitness must be renewed every *THREE YEARS*.
