Job Description:

The DNA Learning Center (DNALC), an educational unit of Cold Spring Harbor Laboratory, has a full-time position for an accomplished biology educator with research experience and a passion for increasing diversity in STEM. This individual will become part of a multi-disciplinary team that designs and supports research experiences to prepare high school students to pursue further study and careers. The position is based at the DNALC's new location in downtown Brooklyn – *DNALC NYC*.

The successful candidate will help develop and oversee programs to expand *DNALC NYC* outreach to underserved and underrepresented students. They will be especially responsible for our “Research Ready” Program, which partners with public high schools to develop project-based learning and research programs in modern biology. They will also instruct labs, course-based research experiences, and intensive summer camps for high school and college students.

Job Requirements:

The successful candidate will have an advanced degree in molecular biology, genomics, bioinformatics, or a relevant field. Working experience in research is essential, as is the ability to transform an idea into a finished product. They must also be able to cultivate and maintain strong relationships with partner schools.
